Chairperson Unthank recognized Mayor Owens. Mayor Owens introduced Cherlyn Kee. Ms. Kee represents Lexington County Recreation and Aging Commission – Tri-City Senior Center. Mayor Owens presented Ms. Kee with a proclamation to designate March 2015 as the National March for Meals Month.

Agenda Item VI – Approval of Minutes for Previous Meetings

Chairperson Unthank entertained a motion to approve the minutes for the Regular Council meeting held February 3, 2015. Council Member Miles so moved and Mayor Owens seconded. The motion passed unanimously.

Agenda Item VII – Unfinished Business

A. Chairperson Unthank entertained a motion for second reading consideration of an ordinance to relinquish a sewer easement for city property located at 136 Sunset Boulevard. Council Member Miles so moved and Mayor Owens seconded. The motion passed unanimously.

Agenda Item VIII - New Business

- A. Chairperson Unthank entertained a motion for first reading consideration of an ordinance to annex 38.6 acres of property (a portion of TMS# 3698-01-004) off of Henbet Drive. Council Member Miles so moved and Mayor Pro-Tem Hallman seconded. The motion passed unanimously.
- B. Chairperson Unthank entertained a motion for consideration to grant a construction easement to South Carolina Department of Transportation (SCDOT) for Rainbow Drive city sewer pump station property. Sid Varn, Director of Planning and Engineering informed Council the easement is temporary for construction purposes only. Mayor Owens so moved and Council Member Fowler seconded. The motion passed unanimously.
- C. Chairperson Unthank entertained a motion for consideration to approve an agreement for proposed storm water pollution prevention plan for public works/fleet services. Sid Varn, Director of Planning and Engineering, informed Council the storm water prevention plan is mandated by the Environmental Protection Agency (EPA) and administered through South Carolina Department of Health and Environmental Control (SCDHEC.) AMEC Foster Wheeler, an engineering company, has provided this service to the city for the past 3 or 4 years. The fee is \$10,000. Mr. Varn stipulated \$12,000 has been budgeted for this service, and recommended approval for this work by AMEC Foster Wheeler. Mayor Owens so moved and Council Member Fowler seconded. The motion passed unanimously.
- D. Chairperson Unthank entertained consideration of a resolution to authorize the sale and consumption of beer and wine at the Riverwalk Park amphitheater during the spring and fall Rhythm on the River concert series. Council Member Miles so moved and Mayor Owens seconded. The motion passed unanimously.
- E. Chairperson Unthank entertained a motion for a proclamation to designate March 2015 as the National March for Meals Month. Mayor Owens so moved and Council Member Miles seconded. The motion passed unanimously.
- F. Chairperson Unthank entertained a motion to approve a real estate fee agreement proposed by Callison Tighe & Robinson, LLC. Mayor Owens so moved and Council Member Miles seconded. The motion passed unanimously.
